IMF raises India's
FY26 growth

NEW DELHI, 19 JAN

The International Monetary Fund on Monday raised India's GDP growth projection for 2025-26 to 7.3 per cent, a 0.7 percentage point increase from its October estimate, citing better-than-expected economic performance. In its World Economic Outlook update, the IMF also revised India's growth forecast for 2025-26 to 6.4 per cent from 6.2 per cent, while projecting moderation in subsequent years as temporary factors fade. India's GDP grew 8 per cent during April-September 2025-26, supported by 8.2 per cent growth in the July-September quarter. The economy is estimated to expand 7.4 per cent in the current fiscal, up from 6.5 per cent in 2024-25. The IMF said inflation is expected to return close to the RBI's 4 per cent target after easing in 2025 due to softer food prices.

Rajasthan May Need Additional Coal Capacity by 2036

Rising demand prompts review of coal power needs

JAIPUR, 19 JAN

Rajasthan, India's leading renewable energy-producing state, is set to significantly recalibrate its power strategy, with official projections indicating the need for an additional 4,400 megawatts of coal-fired generation capacity by 2036 to meet rapidly rising electricity demand. The assessment underscores the growing challenge of balancing ambitious clean energy goals with the requirement for reliable, round-the-clock power supply.

According to documents of the Central Electricity Authority (CEA), the revised estimate marks a sharp increase from the earlier projection of 1,900 MW of new coal-based capacity for the state. The upward revision reflects accelerating power consumption driven by economic growth, urbanisation and industrial expansion, as well as the practical limitations

of renewable energy sources, which remain dependent on weather conditions.

Even as Rajasthan continues to aggressively expand solar and wind capacity, it is also preparing to retire around 1,350 MW of ageing coal-fired plants that have completed their operational life. The simultaneous phase-out of old thermal units and rising demand has widened the gap between generation needs and dependable baseload supply, prompting policymakers to reassess the role of coal in the state's future power mix.

At the national level, India meets nearly one-third of its electricity demand through thermal power and has committed to achieving net-zero emissions by 2070, alongside expanding renewable energy capacity to 500 gigawatts.

However, government projections indicate that overall power demand will surge in the coming decade, requiring

a substantial increase in firm generation capacity. Coal-based capacity nationwide is expected to rise by about 40% by 2035 to ensure grid stability.

In Rajasthan, the revised coal requirement has led the state electricity regulator to review its earlier decision denying approval for a proposed 3,200 MW coal-based power plant. The state power plant

has maintained that additional coal capacity is unavoidable at present, citing the intermittent nature of solar and wind energy and the absence of commercially viable, large-scale battery storage. Despite deriving nearly 70% of its power from renewable sources, the state now faces a critical policy choice between energy security and long-term decarbonisation goals.

HC denies relief to Sengar in custodial death case

NEW DELHI, 19 JAN

The Delhi High Court on Monday refused to suspend the 10-year jail term of expelled BJP leader Kuldeep Singh Sengar in the custodial death case of the Unnao rape survivor's father due to delay in trial.

The judge observed that while Sengar has undergone incarceration of about seven-and-a-half years, relief could not be granted on the ground of

delay alone, as the appellant had repeatedly moved applications for interim suspension, extension of bail and regular suspension of sentence.

Purpose would be served if the appeal were heard on merit in an expeditious manner, the court said.

The survivor expressed satisfaction with the court's verdict, saying the

decision had brought her a sense of solace.

She said those responsible for her sexual assault and her father's death must face the strictest punishment.

Sengar's counsel said that his continued incarceration would cause grave and irreparable prejudice as the appeal itself could

become infructuous. The court said that Sengar was a key conspirator and that the assault on the deceased and the falsification of the FIR were part of that design. In 2020, a court had sentenced Sengar to 10 years rigorous imprisonment and imposed a fine of Rs 10 lakh, in the case. It had also awarded a 10-year jail term to Sengar's brother, Atul Singh Sengar, and five others for their role in the custodial killing of the rape survivor's father.

SC Allows Rajasthan Highway Liquor Shops Open

JAIPUR, 19 JAN

Around 1,102 liquor shops located on national and state highways within municipal limits in Rajasthan will remain operational after the Supreme Court granted an interim stay on a Rajasthan High Court order directing their removal and relocation. The order was passed by a Bench comprising Justice Vikram Nath and Justice Sandeep Mehta while hearing special leave petitions filed by the state government and affected licence

holders.

Appearing for the state, Solicitor General Tushar Mehta and Additional Advocate General Shivamangal Sharma argued that previous Supreme Court judgments had already relaxed the 500-metre restriction for liquor vends within municipal limits.

It is contended that the High Court could not override the law laid down by the apex court.

Earlier, the Rajasthan High Court had directed the removal of liquor shops within 500 metres of highways, citing public safety under Article 21 of the Constitution, despite an estimated revenue loss of nearly Rs. 2,100 crore. The interim stay allows the shops to continue operating until further orders. Final hearing awaited in matter.

NSUI Protests Assault Incident at MBM Sports Complex, Demands Stronger Campus Security

JODHPUR, 19 JAN

The National Students' Union of India (NSUI) has lodged a strong protest over a recent incident of serious violence between two groups of students at the sports complex of MBM University. Led by NSUI District President Dr Bablu Solanki, a delegation submitted a memorandum to the university registrar, demanding immediate strengthening of security arrangements across the campus. Dr Solanki said that incidents of violence in an academic environment such as a university are highly condemnable. He stated that such incidents not only create fear among students but also damage the institution's reputation among parents and society at large. He alleged that the lack of adequate security measures and effective monitoring within the campus has contributed to the occurrence of such incidents. Through the memorandum, NSUI demanded that security be reinforced across the university, including the sports complex. The organisation called for the identification of students involved in the assault and strict disciplinary action against those found guilty. It also urged the administration to increase regular patrolling, enhance CCTV surveillance and deploy additional security personnel to ensure a safe environment for students.

NSUI leaders stressed that concrete and long-term arrangements must be put in place to prevent the recurrence of such incidents in the future and to restore a sense of safety and confidence among students on campus.

Indore Tourist Dies After Sudden Illness During Jaisalmer Trip

JAISALMER, 19 JAN

A 35-year-old tourist from Indore died after his health suddenly deteriorated while visiting the Sam sand dunes near Jaisalmer, police said on Monday.

The deceased was identified as Rahul Malviya, son of Harinarayan, a resident of Indore in Madhya Pradesh. He had arrived in Jaisalmer with a group of five to seven friends for a leisure trip.

According to officials, the group reached the Sam area on the night of January 18 and was watching an evening cultural programme at a resort located amid the sand dunes when Rahul suddenly fell ill and collapsed.

Resort staff and his friends rushed him to the community health centre at Sam. Due to the seriousness of his condition, he was referred to the district hospital in Jaisalmer.

However, doctors declared him dead on arrival at the district hospital.

Jaisalmer Deputy Superintendent of Police Roop Singh India said preliminary information indicated that the cause of death may have been a silent heart attack.

The body has been kept in the mortuary, and further action, including a post-mortem examination, will be carried out to ascertain the exact cause of death.

Delhi choked under a blanket of smog on Monday morning, with the average Air Quality Index (AQI) settling at 417 in the 'severe' category. As per the Central Pollution Control Board (CPCB) Sameer app, AQI data for one station was not available while writing this report. Wazirpur, which recorded an AQI of 474, had the worst air quality among all stations. The air quality was 'severe' at 25 stations, and 'very poor' at 14 stations. No improvement in air quality is likely in the next two days.

Man murders his live-in partner, burns body

JHANSI, 19 JAN

A woman, 33, was murdered with an axe allegedly by her live-in partner, who then burnt her body inside a large trunk, police said on Monday.

The murder came to light on Sunday due to the alertness of a loader driver while the accused was attempting to dispose of the body.

Police arrested the main accused, a retired railway employee, Ram Singh Parihar, 63, along with his second wife, Geeta, 50, and son Nitin, 19, for assisting in destroying evidence.

Parihar had married Geeta while his first wife was still alive and was living with her and his children in the Sair Gate area. Later, he developed a relationship with Preeti Ahirwar, 33, the wife of Rajkumar. Preeti left her husband and three children and began living with Parihar.

SSSP BBGTS Murthy said police received information early on Sunday about a suspicious trunk. Police found partially burnt human remains inside. Nitin said that he had brought the trunk from his father's house and that it contained Preeti's remains. Geeta told police that Parihar had killed Preeti after disputes over money.

The SSP praised the loader driver, saying he would be honoured with a certificate, and announced a reward of Rs 25,000 for the Sipri Bazaar police team for cracking the case within hours. He added that although the victim has been identified, samples from the remains have been sent for DNA testing.

DGCA fine on Indigo won't ensure safety: Pilots fume

Safety can't be traded off for Rs 22.20 crore, says FIP

MUMBAI, 19 JAN

The Federation of Indian Pilots, FIP, on Monday criticised aviation regulator DGCA for imposing a 'very meagre' penalty of Rs 22.20 crore on IndiGo for the large-scale flight disruptions that impacted lakhs of travellers in December, saying that the safety of passengers and aircraft cannot be 'traded off.'

FIP questioned the flight cancellation period considered in the probe by the regulator, and said the penalty amount is "very, very meagre."

The DGCA on Saturday announced the enforcement actions after a detailed probe.

It slapped penalties totalling Rs 22.20 crore on IndiGo for cancelling thousands of flights in early December, and warned airline CEO Pieter Elbers and COO Isidre Proquerias. It also ordered the removal of the Senior Vice President for Operations Control centre (OCC), Jason

Herter, for non-compliance.

Between 3 and 5 December, the DGCA said, 2,507 flights were cancelled, and 1,852 flights were delayed, impacting over 3 lakh passengers.

The DGCA has imposed a penalty of Rs 20.40 crore for

equate regulatory preparedness, along with deficiencies in system software support, as among the primary reasons for the disruptions.

Sikkim man nabbed in Rs 13,000 cr drug case

NEW DELHI, 19 JAN

The Special Cell of the Delhi Police has apprehended a man from Sikkim in connection with a massive Rs 13,000 crore drug trafficking case, sources said on Monday.

The accused, identified as Tilak Prasad Sharma, 40, was allegedly involved in supplying cannabis sourced from Thailand for the same syndicate.

The source said that the arrest is linked to a major crackdown carried out on 2 October, 2024, when cocaine and cannabis worth around Rs 13,000 crore were seized while being smuggled into multiple locations in Delhi, Gujarat and Punjab by a Dubai-based cartel.

This comes weeks after a key



drug supplier, Ritik Bajaj, was caught in Dubai and brought back to India by the authorities.

Deputy commissioner of police (Special Cell), Kaushik said Tilak Prasad Sharma was arrested in Sikkim and brought to Delhi. "Sharma had brought a consignment of around 40 kg of Thai marijuana from Thailand at the direction of Ritik."

Kukis demand justice for gangraped woman

CHURACHANDPUR, 19 JAN

Several organisations demanded justice for a Kuki woman from Manipur, who died recently from illness allegedly linked to the trauma she suffered after being gangraped during the early phase of the ethnic violence in the state in 2023.

The Kuki organisations based in Manipur's Churachandpur and Delhi claimed that she was kidnapped in Imphal and gangraped in May 2023. She, however, escaped from the kidnappers, but never fully recovered from the shock and injuries and died on 10 January while undergoing treatment in Guwahati.

The groups also demanded a separate administration for the Kukis, claiming that it was not possible for them to live with the Meitei community any longer.

Prince Harry returns to London's High Court this week for the final phase of his lawsuit against British tabloids, seeking damages worth millions. The Duke of Sussex leads high-profile claimants, including Elton John and Elizabeth Hurley, according to Associated Newspapers Ltd of unlawful information-gathering and privacy breaches, claims the publisher calls "preposterous." The nine-week trial marks Harry's second time in the witness box after becoming the first senior royal in over a century to testify in 2023. Harry blames the press for Princess Diana's 1997 death and attacks on Meghan. Filed in 2022, a judge said the claims have prospect of succeeding.

Karachi mall blaze leaves 26 dead, 65 still trapped

KARACHI, 19 JAN

The death toll from a fire at Gul Plaza in Karachi has risen to 26 after rescue teams recovered eight more bodies from the rubble. The blaze broke out on Saturday night at the wholesale and retail market, which had shops across the basement, mezzanine, and three upper floors, and was controlled by Sunday evening. Six people died immediately from suffocation, while dozens were injured. Rescue 1122 COO Abid Jalal said the building, weakened by the fire, remains at risk of collapse. Sindh Governor Kamran Tessori said 65 people are still trapped. Authorities suspect an electrical short circuit. Karachi has faced repeated fires due to poor safety.

Guatemala orders emergency after deadly prison riots

ESCUINTLA, 19 JAN

Guatemala has declared a 30-day state of emergency after gang members killed at least seven police officers and took dozens of hostages across three prisons. The unrest began on Saturday when authorities limited privileges for gang leaders, including Aldo Duppie, head of the Barrio 18 gang. Police and military raids early Sunday freed all hostages held at prison in Escuintla. Retaliatory attacks by gang members followed, leaving 10 officers wounded and one gang member dead. Interior Minister Marco Antonio Villeda linked the killings to gang reprisals. President Bernardo Arevalo announced mourning, and emphasised of not yielding to criminal threats.

2025 minority incidents non-communal: Bangladesh

NEW DELHI/DHAKA, 19 JAN

The interim government in Bangladesh, led by Chief Adviser Muhammad Yunus, on Monday claimed that the majority of incidents of killing and violence involving minority communities in 2025 were 'criminal in nature' and not driven by communal motives.

Bangladesh and described as "troubling" the attempts to attribute the incidents to extraneous reasons.

Citing a yearlong review of official police records, the interim government said a total of 645 incidents involving minority communities were recorded between January and December 2025 across Bangladesh.

"While every incident is a matter of concern, the data

presents a clear and evidence-based picture: the overwhelming majority of cases were criminal in nature rather than communal," it said.

The statement reiterated that ensuring safety and justice for all citizens, including Muslims, Hindus, Buddhists, Christians and people of other beliefs, remains a constitutional and moral obligation.

The statement came ahead of the 12 February general elec-

tions in Bangladesh, amid the Bangladesh Nationalist Party (BNP) apprehensions about holding free and fair elections in the country by the Election Commission.

BNP secretary general Mirza Fakhrul Islam Alamgir urged the Chief Election Commissioner AMM Nasir Uddin on Sunday to work with "complete impartiality" in the conduct of polls. "However, we are now observing certain issues where arrangements appear biased, and conduct raises concerns. We have urged the commission to act with complete impartiality," he said.

Trump warned that tariffs could rise to 10 per cent from 1 February and 25 per cent from 1 June if no deal was reached, calling the move necessary for national security and saying it was "time for Denmark to give back" after years of US support.



Mid-day meal cooks protest Rs 66 pay/day in Raipur

It's been 22 days since thousands of mid-day meal cooks, mostly women, have been protesting in Chhattisgarh capital Raipur, demanding a hike in their daily wages from Rs 66 to over Rs 400.

Nearly 95 per cent of the protesters are women, many from rural and tribal areas, who say their labour keeps classrooms running, even as their own households remain on the brink.

These cooks, the key workforce behind one of the government's ambitious nutrition schemes, have been protesting under the banner of the 'Chhattisgarh School Madhyan Bhojan Rasoiya Samyukta Sangh'.

"Why is the government playing with our lives?" asked Savita Manikpuri (38), who travelled from Kanker district to join the agitation.

A cook since 2011 at a government middle school in Duhawa village, Manikpuri recalled starting on a monthly honorarium of Rs 1,000, later raised to Rs 2,000 during the previous Congress government.

"Governments change, but our situation doesn't. How do we survive on Rs 66 a day?" she asked while talking to PTI on Monday.

"I have two children. My daughter has finished school, but I can't afford to send her to college. My son is in Class 11. They have dreams. I don't know how to fulfil them," she said.

Meghraj Baghel (45), the protesting association's secretary, said around 87,000 cooks work under the mid-day meal scheme in the state, and since December 29, they have been on an indefinite strike, a move he claimed has disrupted meal services in several schools.

Groups of cooks arrive in batches from different districts, stay for a few days, and then return home, replaced by others. On any given day, 6,000 to 7,000 cooks sit in protest, he claimed.

Baghel said he has been asso-

ciated with the scheme since its launch in October 1995.

"We began at Rs 15 per day. After 30 years, we are still at Rs 66. Our demand is simple - pay us the collector rate, around Rs 440 per day," he said.

Baghel claimed the state government has done nothing for the cooks.

They are paying monthly wages of only Rs 2,000, that too for 10 months in a year. In contrast, cooks in other states receive significantly higher wages for the same work - Rs 21,000 per month in Puducherry, Rs 12,000 in Kerala, Rs 6,000 in Lakshadweep, Rs 4,000 each in Madhya Pradesh and Haryana, he said.

Baghel said that given the crushing inflation, it is becoming increasingly difficult for them to make ends meet.

Beyond wages, the cooks say their jobs are precarious.

"When schools are merged, or student strength declines, cooks are often removed. We have given our entire lives to this work. If a school closes,

where do we go?" Baghel asked, demanding that they be given alternative employment within the government setup.

Another protester, Bhuneshwari Markam (40) from Mathuradih village of Dhamtari district, has been cooking mid-day meals for 15 years.

"We reach school for work by 9 am and leave after 3 pm. Cooking, serving, washing utensils, it takes five to six hours. Yet the government says we work only two hours," she rued.

Markam's family depends on her income and her labourer husband's daily wages.

"We don't have farmland. This is our main source of income. We feed other people's children, but we cannot properly feed our own. Education, clothes, even basic needs are a struggle," she claimed.

Many women at the protest site spoke of long-term health problems due to smoke, as in rural areas, meals are often prepared on firewood stoves due to the unavailability of cooking gas cylinders.

The women said they will continue to stage the protest until the government listens to their demands.

Pramod Ray, the association's media in-charge, who works as a cook at a school in Nawagaon village of Bemetara district, also highlighted the health hazards faced by cooks, especially in rural areas where food is still prepared on firewood stoves due to the unavailability of cooking gas.

"Many suffer from eye problems and respiratory illnesses. My mother, who earlier worked as a mid-day meal cook, has been suffering from a heart-related ailment and has been under treatment for 6-7 years. In the rainy season, the work conditions worsen. Despite years of service, we are treated like bonded labourers," he claimed. The state education department officials could not be contacted for a response despite repeated attempts.

State Congress chief Dipak Baij visited the protest site on Monday and extended support to the demands of the cooks.

'Billionaires have 4,000 times more chance at politics'

As the rich and powerful from across the world start filling snow-clad lanes here, a new study said billionaires are 4,000 times more likely to hold any political office than ordinary people.

It also said their wealth jumped three times faster in 2025 than the past five-year average to a record high of \$18.3 trillion. In Indian currency, it translates to more than Rs 1,660 lakh crore.

Hours before the 56th World Economic Forum Annual Meeting 2026 begins in this Swiss ski resort town, rights group Oxfam International released its own annual inequality report to highlight that the ever-deepening wealth divide was also sparking dangerous political inequality.

The meeting is being attended by over 3,000 global leaders, including more than 60 heads of state or government, as part of an over 400-strong political leadership presence in this small town in the Alps.

Oxfam International said the billionaire wealth jumped by over 16 per cent in 2025, while it has increased by 81 per cent since 2020.

"This comes as one in four people don't regularly have enough to eat, and nearly half the world's population live in poverty," it added.

The report, titled 'Resisting the Rule of the Rich: Protecting Freedom from Billionaire Power', analysed how the super-rich were securing political power to shape the rules of our economies and societies for their own gain and the detriment of the rights and freedoms of people around the world.

Oxfam said the surge in billionaire wealth coincided with the US Trump administration pursuing a pro-billionaire agenda, as it has slashed taxes for the super-rich, undermined global efforts to tax large corporations, reversed attempts to address monopoly power and contributed to the growth of AI-related stocks that have provided a boon to super-rich investors worldwide.

Trump is among the top global leaders attending the WEF. Oxfam said the Trump presidency has sent a clear warning sign to the rest of the world about the power of the ultra-rich and rising oligarchy, which is undermining societies worldwide rather than being solely a US phenomenon.

It said the collective wealth of billionaires last year surged by \$2.5 trillion, almost equivalent to the total wealth held by the bottom half of humanity, or about 4.1 billion people.

This increase itself would be enough to eradicate

extreme poverty 26 times over, it pointed out.

The number of billionaires topped 3,000 last year for the first time, while the richest, Elon Musk, became the first ever to surpass half a trillion dollars.

"The widening gap between the rich and the rest is, at the same time, creating a political deficit that is highly dangerous and unsustainable," Oxfam Executive Director Amitabh Behar said. It cited a 'World Values Survey' of 66 countries that found that almost half of all people polled say that the rich often buy elections in their country.

Billions of people are being left facing avoidable hardships of poverty, hunger and death from preventable diseases because the system is rigged against them, while one in four people worldwide face food insecurity, having to regularly skip meals, Oxfam said. It further said civil liberties and political rights are being rolled back and suppressed, while last year there were more than 142 significant anti-government protests across 68 countries, which authorities typically met with violence.

"Being economically poor creates hunger. Being politically poor creates anger," Behar said.

The chances of democratic backsliding through, for example, the erosion of the rule of law or the undermining of elections, are seven times more likely in

highly unequal countries, the Oxfam report said.

Oxfam further said governments are allowing the super-rich to dominate media and social media companies, as billionaires own more than half the world's largest media companies and all the main social media companies.

It cited Jeff Bezos' purchase of the Washington Post, Elon Musk with X, Patrick Soon-Shiong with the Los Angeles Times and a billionaire consortium buying large shares of The Economist.

In France, Far-Right billionaire Vincent Bolloré now controls CNews, rebranding it as the French equivalent of Fox News. In the UK, three-quarters of newspaper circulation is controlled by four super-rich families.

The report further flagged that only 27 per cent of top editors globally are female and just 23 per cent belong to racialised groups.

Oxfam called on governments to prioritise realistic and time-bound National Inequality Reduction Plans, effectively taxing the super-rich to reduce their power, and ensuring stronger firewalls between wealth and politics. It also sought accountability for political empowerment of ordinary citizens, including stronger protection for people's freedoms of association, assembly and expression and for civil society organisations and trade unions.

Nabin rose through the ranks

MLA at 26 and BJP president at 45, Nitin Nabin's ascent has been nothing short of storybook. Elected unopposed on Monday as BJP's youngest National President, his elevation signals a clear generational shift as the party looks to further consolidate its grip on national politics.

A low-profile but seasoned leader, Nabin is a five-term MLA from Bihar and the state's Public Works Department minister. He was appointed BJP working president on 14 December, a move that ended prolonged speculation over who would succeed veteran JP Nadda and surprised political circles amid

buzz of differences between the BJP and its ideological mentor, RSS, over the appointment. The unassuming leader, who now has the task of steering the party through a packed electoral calendar, including Assembly elections in Tamil Nadu, Kerala and Assam due in April, has hit the ground running. The first BJP chief from Bihar, Nabin has toured several states since his appointment, delivering a sharp and direct message to party workers.

"Politics is not a 100m race but a long marathon. It is not a test of speed but of patience and stamina," he has repeatedly told cadres. In Bihar, he urged workers to think

beyond immediate electoral gains. "We have to unfurl bhagwa... from panchayat to Parliament... unlike part-time politician Rahul Gandhi, who comes during polls and goes to Germany for holidays," he said.

The upcoming state elections will be a crucial test for Nabin, who rose through the ranks of the Bharatiya Janata Yuva Morcha, to prove his mettle as the organisational head of the party pyramid.

Nabin entered mainstream politics in 2006 after the death of his father, Navin Kishore Sinha, a veteran BJP leader with close RSS ties. Forced to leave his studies midway, he

was initially seen as an outsider. Two decades on, he is regarded as a grounded organisation man.

Now 45, Nabin has won five consecutive elections from the Bankipur seat, often by huge margins. He impressed the central leadership as BJP co-in-charge of the 2023 Chhattisgarh Assembly elections, where the party scored a surprise win, and repeated the success in the Lok Sabha polls, winning 10 of 11 seats in the state. He joins a distinguished line of BJP presidents, from Atal Bihari Vajpayee and LK Advani to Amit Shah, succeeding Nadda, who held the post since 2020.

Nadda ends tenure with strong legacy

After Jagat Prakash Nadda took over as the BJP's 11th national president six years ago, rising steadily through the ranks over a period of three decades, Prime Minister Narendra Modi had expressed confidence that the party would scale new heights under his leadership.

True to that trust, Nadda delivered a notable legacy, leading the party as it consolidated strongholds and expanded its footprint despite occasional setbacks, before handing over the baton to his successor Nitin Nabin, elected unopposed as the new BJP Chief on Monday.

During his tenure, the BJP secured a series of wins in the assembly polls. While the party wrested Madhya Pradesh, Chhattisgarh and Rajasthan from the Congress, it ended Naveen Patnaik's 24-year rule as Odisha chief minister by decimating the BJD in the assembly elections.

Under Nadda's stewardship, the BJP also returned to power in Delhi in 2025 after more than 26 years by inflicting a crushing defeat on the Arvind Kejriwal-led AAP in the 2024 Lok Sabha polls.

record number of seats and propelling ruling Mahayati to a landslide victory.

The NDA's thumping victory in the Bihar assembly polls towards the end of 2025 consolidated the BJP's electoral dominance under Nadda's watch after the BJP's overwhelming performance in the 2024 Lok Sabha polls.

When Nadda assumed the party's reins on 20 January, 2020, the BJP was in power in 15 states, with its chief ministers in just seven. Today, the party holds power in 20 states and Union Territories alongside its partners in the NDA, and has its chief ministers in 14 of them.

Nadda's ability to deliver these results stems from a long journey rooted in his early political activism and years of experience in building, managing and running political structures.

Born to Krishna and Narain Lall Nadda in a Brahmin family on 2 December, 1960, Nadda did his schooling from St Xavier's school in Patna and earned a Bachelor of Arts degree from Patna University.

Nadda's journey so far has been a striking testament to discipline, conviction and unwavering dedication to public life, according to BJP leaders. He was just 15 when he participated in a relay fast in a

movement spearheaded by Jai Prakash Narayan against the then Congress chief minister of Bihar Abdul Gafur.

In 1991, Nadda became the national president of the Bharatiya Janata Yuva Morcha (BJYM) and came in touch with the then BJP chief Murli Manohar Joshi.

Nadda won the assembly election from the Bilaspur seat, contesting on the BJP ticket, and became the Leader of the Opposition in the Himachal Pradesh Legislative Assembly in 1993. He was re-elected from the seat in 1998 and became a cabinet minister in the BJP government for the first time.

In 2010, the BJP appointed Nadda as the party's national general secretary after Nitin Gadkari took over as the BJP chief. When Amit Shah took the reins of BJP as its national president in 2014, Nadda was also made a member of the party's parliamentary board, the highest decision-making body of the organisation. Nadda eventually took over as BJP chief in 2020.

After BJP-led NDA returned to power for a third consecutive term under Prime Minister Narendra Modi's leadership in 2024, Nadda was appointed as Union minister for Health and Family Welfare as well as Chemicals and Fertilisers.

Rupee ends 14P lower at 90.92 against USD

MUMBAI, 19 JAN

The rupee breached the 91-a-dollar mark for the second time in a month before ending 14 paise down at 90.92 (provisional) against the greenback on Monday, as renewed concerns over global trade uncertainties accelerated foreign fund withdrawal. Despite weak

American currency and lower crude oil prices, selling pressure in domestic equities pushed the Indian currency downward, forex analysts said. At the interbank foreign exchange, the rupee opened at 90.68 and slid past the crucial 91.01 against the greenback. It finally settled 14 paise lower at 90.92 (provisional)

against the dollar, just 1 paise above its record low closing level. On Friday, the rupee crashed 44 paise to settle near its lowest level at 90.78 against the US dollar, after losing 17 paise in the preceding two sessions.

The dollar index, which measures the greenback's strength against six currencies, traded 0.23 per cent lower at 98.97.

Tech Mahindra shares rise by 4% post Dec earnings

NEW DELHI, 19 JAN

Shares of IT services firm Tech Mahindra rose nearly 4 per cent on Monday after the company reported a 14.11 per cent increase in net profit for the December quarter of FY26. The stock advanced 3.80 per cent to Rs 1,734.05 on the BSE and 3.85 per cent to Rs 1,734.90 on the NSE. The results were announced after market hours on Friday. The Mahindra Group Company posted a profit of Rs 1,122 crore, compared with Rs 983.2 crore in the year-ago period. Revenue from operations increased to Rs 14,393 crore from Rs 13,286 crore a year earlier. During the quarter, Tech Mahindra secured new deals worth USD 1,096 billion. CEO and MD Mohit Joshi said the deal pipeline remains robust across all geographies and verticals.

BHEL's Q3 profit surges threefold to Rs 390 crore

NEW DELHI, 19 JAN

Bharat Heavy Electricals Ltd (BHEL) on Monday posted a three-fold jump in consolidated net profit to Rs 390.40 crore for the December quarter, mainly due to increased revenues from key sectors. The company had clocked a net profit of Rs 134.70 crore in the October-December period of the preceding 2024-25 fiscal, as per an exchange filing. BHEL's total income rose 18 per cent to Rs 8,691.85 crore during the third quarter from Rs 7,385 crore in the year-ago period.

From the power segment, the company earned a revenue of Rs 6,322.36 crore compared to Rs 5,588.45 crore a year ago. BHEL achieved a revenue of Rs 2,150.74 crore in October-December, up from Rs 1,688.64 crore in the year-ago period.

Govt partially lifts ban on export of wheat flour

NEW DELHI, 19 JAN

The government has permitted the export of up to five lakh metric tonnes (LMT) of wheat flour and related products, partially easing a ban that has been in place since 2022. The Directorate General of Foreign Trade (DGFT) said in a notification dated 16 January, that exports will remain prohibited beyond this quantity. Exporters must obtain prior authorisation from the DGFT. The first round of applications will be accepted from 21

January to 31 January, 2026. Thereafter, applications will be invited during the last ten days of each month until the permitted export quantity is fully allocated. Each export authorisation will be valid for a period of six months from the date of issue. Eligible applicants include flour mills and processing units having valid Import Export Code (IEC) and FSSAI licences operating as manufacturer-exporters.
